## 2 Print View; Urgent Details

Where a referral has been marked as 'Urgent', this should appear at the top of the referral form in bold and red, followed by the 'Urgent reason' field details:

## **3** Patient Residential DHB

#### 3.1 Patient Residential DHB Concepts

The following concepts to be created and maintained for patient residential DHB:

- 1. 'patient.residentialDHB': Current code which maps the raw DHB code to a predefined 'facility' code
- 2. 'patient.residentialDHB.code': raw DHB code
- 3. 'patient.residentialDHB.description': DHB description

Where the 'patient.residentialDhb' is provided by the EMR the Critchlow value will override (if value determined) and this logic will be maintained for the new MoH system.

#### 3.2 Patient Residential DHB Dropdown

Non-mandatory dropdown added to 'Patient Information' tab for user to select 'Patient Residential DHB' when geocode is not found.

## 4 Preview Attachment Content

This section of the document defines the requirements for the functional extension of the existing 'Attachments / Reports' table in the core form. These changes apply to all services and templates The requirement is to allow the user to 'preview' the full content of attachments to help identify the attachments for selection (attachments often have poor naming conventions.

#### 4.1 Attachments Table 'Preview' button

A new column will be added to the attachments table with a 'Preview' button so the user can select which attachment they would like to Preview (for all attachment types):

#### 4.2 Preview Light box

Once the user clicks on the row they want to preview using the preview button one of two views will be displayed depending on the attachment type:

1. **RTF & TXT attachments**: A light box will appear displaying the contents of the attachment in a light box on the screen:

2. All other attachment types: the attachment will launch in the native application of the attachment e.g. adobe for PDF, word for doc.
